 - i. Expiration Dates not integrating correctly to Other IDs, mainly with reverifications
 - ii. Working with our Integrations team and Guardian to resolve
 - iii. For now, use Workers With Other IDs to check Expiration Dates and Workers With No Other ID for missing dates.
- b. Update: Remote Processing Procedure HAC Vote
 - i. Approved by HAC, current plan for feature availability is 3/1 for those who opt in
- c. AG: Removing occupation class defaults
 - i. Any others having trouble with this?
 - ii. TAMU/TTI – trying giving them Full Feature HR access?
- d. I-9 Everywhere
 - i. Looked into this solution, does this fit for our needs/budget
 - ii. Outsource completions
 1. Recommendation is for remote form I-9
 - iii. Approx cost per I-9 is \$63+ if contracted for a minimum of 2500 I-9s
 1. 2023 has a total of 2,435 remote Form I-9s across the system
 2. Also PayGo option at \$74+ per Form I-9
 - iv. Can opt-in by Member
