ITSS Operations Updates – Sri Kamarthi

- Verifications for the Social Security Number (SSN) quarterly reviews are now available in File Depot for the August 31st file run
- The Texas Comptroller has completed the annual TINS purge. We have processed a full TINS file (covering all employees) to confirm that all TINS remain active. Weekly TINS Error Reports will continue to be sent to each member as applicable
- Please be on the lookout for a W-2 kickoff email, along with additional W-2 information

- New System regulation requiring visual verification at the help desk for each member, via teams, zoom, etc.

New Earning Codes – Sri Kamarthi

- Below earning codes have been created to support LEO Incentive Grant Allowances. First payments for these allowances will be in October.

Earning Code Name	Earning Code
Associate's Degree Incentive Grant - Peace Officer	ADIG
Bachelor's Degree Incentive Grant - Peace Officer	BDIG
Master's Degree Incentive Grant - Peace Officer	MDIG
Intermediate Certification Incentive Grant - Peace Officer	ICIG
Advanced Certification Incentive Grant - Peace Officer	ACIG
Masters Certification Incentive Grant - Peace Officer	MCIG

- **Education:** Formal degrees earned at an accredited institution of higher education.
 - Associate's degree: \$1,200/yr.
 - Bachelor's degree: \$2,400/yr.
 - Master's degree: \$3,600/yr.

- **Certification:** Certifications awarded by the Texas Commission on Law Enforcement.
 - Intermediate: \$1,200/yr.
 - Advanced: \$2,400/yr.
 - Masters: \$3,600/yr.

- *One-Time Merit Payment Plan – Gross up* has been created to facilitate gross up merit payments

New Arrears Tab – Sri Kamarthi

- Workers can view their current arrears balance totals and details through both employee worker profile
 - Better insights into their net pay and autonomy over accessing the information

Timesheets lockout – Sri Kamarthi

- Adding more time before timesheets are locked
 - Currently we can go back 3 pay periods to adjust timesheets. Should we extend this to 6 pay periods?

Everyone agrees this would be a helpful change
Next this will go to the time and absence working group for discussion
